Prince Albert Municipality is looking for a service provider to undertake background checks on all prospective candidates to be employed by the Municipality. The following checks should be performed on each prospective candidate:

- Any pending criminal cases, violations incurred by the candidate.
- Citizenship
- Validation of Identity number, and Identity verification

- Verification of Matric (Grade 12) Verification with Umalusi or the various Provincial Departments of Education
- Verification of National Tertiary Qualification (degrees, diplomas or certificates)
