1 RESIDENTIAL PROPERTIES

Rebate on the First R15 000 of the market value of all residential properties according to Section 17 (1)(h) of the Municipal Property Rates Act, Act 6, of 2004

2 RETIRED PERSONS (60 YEARS AND OLDER)

Retired Persons 60 years and older not qualifying for any other rebates in terms of the Property Rates Policy qualifies for an additional 35% rebate on the property rates subject to paragraph 21(a)(i) of the approved Rates Policy

3 INDIGENT HOUSEHOLD

Household where totale income are less or equal to 2 state funded pensions (R6 500) qualify for rebate up to R 70 000 of the valuation which amount included the R 15 000 as per section 17 (1)(h) of the MPRA

4 MUNICIPAL PROPERTIES

Municipal Owned Properties are exempted from paying Rates Section 20.1(a) of the approved Rates Policy

5 PUBLIC SERVICE INFRASTRUCTURE

The first 30% of the valuation of all public infrastructure as defined in Section 17 (1)(a) of the MPRA are exempted from rates as they provide essential facilities and services to the community.

Rates tariff must be calculated according to the Municipal Property Rates regulations of March 2010 (Government Gazette Number 33016)
