DETAILS OF THE PROJECT

Drilling of boreholes

General description of drilling works

The services to be rendered under this Contract include:

- Drilling, insertion of steel and uPVC casing and screens and blow yield testing of two (2) water boreholes near Leeu Gamka and three (3) near Klaarstroom;
- Aquifer testing on successful boreholes; and
- Installation of submersible pumps

The Drilling Contractor will provide all labour, transport, plant, tools, materials including water for drilling and appurtenances necessary to satisfactorily complete the drilling programme as to the specifications determined by the Hydrogeological Consultant. It is imperative that the Drilling Contractor supplies equipment of a suitable size and capability to drill the boreholes up to 300 m if so required.

Pump testing of borehole

After completion of the boreholes the safe yield of each shall be determined by pump testing according to the specifications in the Pump Testing Section.

The contractor shall provide all mechanical labour, accommodation, toilets, transport, plant, tools, materials and accessories, and shall perform all work necessary to satisfactorily complete the controlled testing in accordance to specification and any further details as may be ordered by the Consulting Hydrogeologist.

Testing will be done according the DWS minimum requirements and the SANS 10299-4:2003 Development, maintenance and management of groundwater resources guideline, Part 4: Test-pumping of water boreholes.

The services to be rendered are the execution of:

- A Step Test (also called a Step Drawdown Test).
- A Constant Discharge Test.
- A Water Level Recovery Test.
- Monitoring of Observation Boreholes during Testing.

Borehole pump installation

Although the boreholes have still to be drilled and tested, the pump installation is also included in the tender. It is foreseen to install 2-3 submersible pumps at Klarstroom and 1-2 submersible pumps in Leeu Gamka.

Description of site and access

Klaarstroom

The three sites are within 5 km of Klarstroom and along existing dirt tracks/roads.

Leeu Gamka

The two sites are within 3 km of town and a long existing track.

NATURE OF SURFACE, GEOLOGICAL AND DRILLING CONDITIONS

The boreholes at Klarstroom are expected to penetrate ± 10 m of unconsolidated sand and weathered shale, followed fresh shale/siltstone of the Bokkeveld Group. Drilling conditions are rated as good to fair with moderately hard rock, the latter which can be fractured in narrow, 0.5 - 2 m wide, zones. Fairly low blow-yields of up to 5 L/s or more can be expected.

The boreholes at Leeu Gamka are expected to penetrate ± 10 m of unconsolidated sand and weathered shale, followed fresh mudstone/siltstone of the Abrahamskraal fm of the Beaufort Group. Drilling conditions are rated as good to fair with moderately hard rock, the latter which can be fractured in narrow, 0.5 - 2 m wide, zones. Fairly low blow-yields of up to 5 L/s or more can be expected.

SPECIFICATIONS

1 REQUIREMENTS

1. A suitable person or organization with at least 5 years' experience in Occupational Health and Safety relating to construction projects.

Legal framework of the appointment

Under the current Construction Regulations, the responsibilities and liabilities to ensure health and safety on a project remain with the client and failure to comply with these regulations is a criminal offence.

As set out in regulation 5(6) of the Regulations, the client may appoint a competent person as an Agent in writing to act as the client's representative, in which case the responsibilities applicable to the client shall as far as is reasonably practicable, apply to the appointed Agent.

2. Registration with the South African Council for Project and Construction Management Professions (SACPCMP) is mandatory.
3. The person or organization must provide its own vehicle and accommodation
4. The person must comply with all registration and qualification requirements as per the Occupational Health and Safety Act, in particular the Construction Regulations 2014.

Proposed scope of work

The scope of work of the Agent will in general cover the requirements of regulation 5 of the Regulations. More specifically, it will entail the following:

- 4.1 Provide a project specific health and safety specification to the Principal Contractor. This was done by including a generic specification in the tender documents which allowed all tenderers to allow for the cost of complying with the Regulations in their tenders. The Agent will have to check the generic specifications to determine whether it is project specific and adequate; and update this specification before the work on site commences.
- 4.2 Ensure that the principal contractor to be appointed has the necessary competencies and resources to carry out the construction work safely.
- 4.3 Take reasonable steps to ensure all contractors appointed by the client to comply with these Regulations.
- 4.4 Ensure before any work commences on a site that the principal contractor is registered and in good standing with the compensation fund or with a licensed compensation insurer as contemplated in the Compensation for Occupational Injuries and Diseases Act, 1993 (Act No. 130 of 1993).
- 4.5 Discuss and negotiate with the Principal Contractor the contents of his draft health and safety plan for final approval for implementation to ensure that it covers all the aspects it is required to in terms of the Act. This will be done as soon as is practicable after the Contractor has been appointed, but before any construction work is executed.
- 4.6 Finally approve the health and safety plan for implementation. This will also be done before the Contractor will be allowed to commence with the construction work.

4.7 Take reasonable steps to ensure that each contractor's health and safety plan contemplated in regulation 7(1) (a) is implemented and maintained.

4.8 Ensure that periodic health and safety audits and document verification are conducted at intervals mutually agreed upon between the principal contractor and any contractor, but at least every 30 days.

4.9 Ensure that a copy of the health and safety audit report contemplated in the paragraph above is provided to the principal contractor within seven days after the audit.

4.10 Stop any contractor from executing a construction activity which poses a threat to the health and safety of persons which is not in accordance with the client's health and safety specifications and the principal contractor's health and safety plan for the site.

4.11 Ensure that the health and safety file contemplated in regulation 7(1) (b) is kept and maintained by the principal contractor.

4.12 Manage the health and safety and monitor the execution of the construction work to ensure that this is being done in accordance with the Contractor's health and safety plan for this contract.

- Monitoring by the Agent will be carried out at an absolute minimum of 1 time per month, but the responsibility remains with the Agent to ensure that all Health and Safety requirements are adhered to, thus inspections

may be required on a weekly or daily basis, at the appointed Agent's discretion.

- Monitoring will consist of a walk through inspection of the site together with the auditing of all registers and documents that the Principal Contractor and Sub-Contractors are required to maintain.
- A monthly non-compliance report must be submitted to the client in whom all instances where the Principal Contractor has deviated from the requirements of his health and safety plan, together with the actions taken by the Agent, will be recorded.

4.13 On completion of the contract, all relevant documentation generated by the Principal Contractor as well as a final non-compliance report must be submitted to the client.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2011

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated to exceed/not exceed R1 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.5 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

2.1 **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;

2.2 **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;

2.3 **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic

Empowerment Act;

- 2.4 “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 “**comparative price**” means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less .
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**sub-contract**” means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 “**total revenue**” bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 “**trust**” means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 “**trustee**” means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.

- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval

for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.

- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
