1. INTRODUCTION

Prince Albert Municipality hereby invites formal written quotations from suitable service providers for hiring of machinery for compaction and cleaning of the landfill sites in the Prince Albert Municipal Area.

4.2) The Municipality will place orders as and when required during the contract period.

4.3) An official order must be issued before any delivery may be made to the Municipality.

4.4) Non-compliance with the tender conditions and specifications, could lead to breach of

contract and the supplier will be liable for any expenses incurred as effect thereof.

4.5) The Municipality reserves the right to award any item, or the whole of the contract to

one or more successful bidder(s).

4.6) Establishment shall mean that the plant or equipment is delivered and ready for

operation at any of the towns as specified in the pricing schedule.

4.8) The vehicles provided must comply with the Road Regulations and Safety acts. For

adjudication purposes the total cost (establishment & rate) to hire the plant for 24

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

- 1.5) The local content (LC) expressed as a percentage of the bid price must be calculated in accordance with the SABS approved technical specification number SATS 1286: 2011 as follows:
